BACKGROUND

In recent decades, increased natural resource extraction has encroached upon the remaining intact ecosystems of countries in the Asia Pacific region, home of some of the world's richest biodiversity. This includes mining operations, the construction of large dams, and the conversion of forests into agribusiness plantations. These together with infrastructure development and other activities often result in negative impacts on the livelihoods, homes and other needs of the natural resource-dependent poor and marginalized communities and vulnerable groups such as indigenous peoples, farmers, fisherfolk and women. The COVID-19 pandemic has accelerated already existing inequalities. These groups are also among those worst impacted by both COVID-19 and environmental harms such as climate change, biodiversity loss and environmental degradation that threaten full and effective enjoyment of all human rights. Indigenous peoples and women, in particular, are disproportionately affected.

Resource conflicts and environmental crises have increasingly caused local and indigenous communities to unite and take action to uphold their human rights, including the right to a safe, clean, healthy and sustainable environment, rights to water, rights to participate in environmental decision making and access to information, among others. However, these rights are often ignored or repressed. Democratic and civic spaces across the region continue to shrink and actions used to pacify dissent have been increasing in frequency and severity.

The people who strive to protect and promote human rights related to the environment are those who we call environmental human rights defenders (EHRDs). Despite their vital role in supporting conservation, protecting vital natural habitats and calling for development that is sustainable, the 2021 Global Witness report stated that 227 EHRDs were killed in 2020, many of which are indigenous peoples. Eighteen percent of the killings were from the Asia Pacific region, with 29 killings taking place in the Philippines. Most of the killings were reportedly related to environmentally damaging activities such as mining and extractives, agribusiness and logging. Other forms of attacks on EHRDs are increasingly common such as criminalization and detention, harassment and intimidation, militarization, terror-tagging or red-tagging, and physical and psychological harm.

For EHRDs to continue their important legitimate work which supports the achievement of the sustainable development goals, more must be done to address the challenges they face in the region. The forum is a significant milestone as it will be the first dedicated space for EHRDs to come together and safely discuss, learn from each other's experience and formulate their own recommendations for positive change in the region. The recommendations could become a foundation to raise awareness among policymakers, the private sector and other stakeholders in order to encourage policies and practices recognizing the vital role of EHRDs. It is in this context that the UN Environment Programme (UNEP) and the Office of the High Commissioner on Human Rights (OHCHR) along with the Asia Pacific Network for Environment Defenders (APNED) are convening the Asia Pacific Environmental Defenders Forum on 17-19 November 2021 at 10:00-13:00 GMT+7 / Bangkok time which will be held virtually online.
